



Flu Shot Clinics

Help guard yourself and others from the flu!

As always this is a **NO COST SCHOOLCARE wellness benefit.**
It is offered to participating employees, spouses and dependents.

HOW TO SCHEDULE AN ON-SITE CLINIC:

Rite Aid is SCHOOLCARE's preferred vendor. They will provide on-site flu clinics for each of your locations with a minimum of 10 participants. *(If under 10 participants, Rite Aid offers flu vaccine vouchers for distribution to employees. The voucher will allow for a NO COST flu vaccine at a Rite Aid pharmacy.)*

To schedule an on-site clinic(s) please contact Rite Aid by June 1st. Schedule early to secure your preferred date and time.

The first clinics will be scheduled as early as September 7, 2020

CDC RECOMMENDS RECEIVING THE FLU VACCINE:

Employees, Spouses & Dependents age 3 and older as well as retirees are eligible to receive a flu vaccine.



GOOD TO KNOW:

- Once your clinic is scheduled Rite Aid will send a confirmation email. Additional information will be sent in August before the clinics.
 - *To help ensure your clinic runs smoothly, consent forms will be sent prior to the clinic.*
- The accompanying SCHOOLCARE poster is a great way to promote the event and includes information needed.
- We also recommend emailing your employees to notify them about the upcoming on-site clinic(s). Good details to include in the email are:
 - Vaccinations will be administered by a licensed pharmacist
 - Participants **must present** their SCHOOLCARE/Cigna ID card

Frequently Asked Questions

Are there different kinds of Flu Vaccines?

- Yes, there are two kinds. Trivalent and Quadrivalent. Rite Aid offers the Quadrivalent at all on-site clinics, which protects against an additional strain of the flu virus.

Who will be billed?

- NEW this year. Rite Aid will submit the vaccine claims to Cigna for all SCHOOLCARE participants. Participants will see the vaccine(s) as preventive with no cost on their Explanation of Benefits (EOB).
- Rite Aid can bill other insurances directly for all participants who present their ID card.
- Other individuals will be responsible for the cost at the time of service.

What is the cost?

- SCHOOLCARE participants who provide their SCHOOLCARE/Cigna ID card pay \$0.
- Participants who present their other insurance cards pay \$0*.
- Individuals with no insurance will be charged \$28.00 at the time of service.

What if the employer pays for vaccinations?

- If the employer pays for the employee vaccines, please advise Rite Aid when scheduling to bill the employer for the \$28.00 flu vaccines separately for all other employees.

Are other vaccines available?

- Yes. If someone is pregnant, specific CDC recommended vaccines will be provided.
- The vaccines for pneumonia (Prenar 13/Pnuemovax 23), and tetanus, diphtheria, & pertussis (Tdap) will also be available. The shingles vaccine (Shingrix) remains in a very limited supply, so we recommend calling your local Rite Aid to be added to a list.

**Pharmacists will confirm upon review of insurance as some may require a co-pay.*
