Participating in the SCHOOLCARE **Good For You!** wellness program is easy! This program will offer you the necessary tools to help you lead a healthier lifestyle. Not only is it free to you, but you can earn CASH incentives! To get started, simply complete the following steps.

### STEP 1: HEALTH ASSESSMENT (HA)

The HA asks questions about specific lifestyle habits. Upon completion, your Member Health Report will highlight your current risk level for each lifestyle habit and give you tips for improving your overall health and well-being. - Click on the “**Take Your Health Assessment**” link to begin

### STEP 2: PHYSICIAN’S LAB FORM or BIOMETRIC SCREENING

A Physician Lab Form, may be submitted if you have completed a physical with lab work by your health care provider after January 1, 2016. Also, if you are unable to attend an on-site screening, you may participate by scheduling a physical/lab work anytime during the plan year and then submit the Physician Lab Form. You can locate and print the Form online at [connect.viverae.com](http://connect.viverae.com).

- Once logged in, click the “**Profile**” tab
- The Physician Lab Form is located under “**Forms and Documents**” on the “**Resources**” page

A Biometric Screening consists of a finger stick to measure your total cholesterol, HDL and LDL cholesterol, cardiac risk, triglycerides, and glucose.

The screening will also check your blood pressure and body composition (including height, weight, Body Mass Index (BMI), and waist measurement). Login to your **Good For You!** Account, then click on “**Notifications**” to reserve a space for an upcoming on-site Biometric Screening.

*Please note: biometrics may only be submitted once per plan year via a Physician Lab Form or on-site event (7/1-6/30).*

### STEP 3: INCENTIVE

Once you’ve completed the HA and Biometric Screening or Physician Form, you will receive a **\$175.00 CASH** incentive (paid at the end of the quarter completed). It’s that easy!

#### Screening Event Highlights

- Appointments are 15 minutes in length
- Biometric screenings will be held from 6:30 - 11:30 a.m. since they do require individuals to fast
- SCHOOLCARE/Cigna participants are welcome to attend any screening location regardless of where they are employed
- Employees, covered spouses, and retirees may participate
- Biometrics will be automatically uploaded to your **Good For You!** Account
